**CITY OF KEARNEY  
PROPOSITION**

Shall the City Limits of the City of Kearney, Missouri, in the County of Clay, State of Missouri, be extended so as to embrace and include all the unincorporated area lying within the following boundary lines and found in the County of Clay:

**Beginning at the intersection of the Northerly right-of-way of 144th Street and the Westerly right-of-way of Interstate 35; thence, Southwesterly along said Westerly right-of-way to the South line of Wilkersons White Birch Estates, a subdivision in Clay County, Missouri; thence Westerly along said South line to the Easterly right-of-way of Nation Road; thence South along said Easterly right-of-way to the Westerly right-of-way of Interstate 35; thence Southerly along said Westerly right-of-way to a point which is 100 feet north of the Northerly right-of-way of N.E. 128th Street; thence Easterly, parallel and 100 feet North of said northerly right-of-way to a point which is 100 feet west of the Westerly right-of-way of Massey Road; thence northerly, parallel and 100 feet West of the Westerly right-of-way of Massey Road to a point which is 100 feet north of the Northerly right-of-way of N.E. 130th Street; thence East, parallel and 100 feet north of the Northerly right-of-way of N.E. 130th Street to the Westerly right-of-way of Missouri State Route 33; thence, North along said Westerly right-of-way to the Southerly right-of-way of 134th Street, also being on the South line of Victoria Estates; thence, West along said South line to the Southwest Corner of Victoria Estates; thence, North along the West line of Victoria Estates to the South line of**

River Bend Estates LTS 1-23; thence, West along said South line to the Southeast corner of River Bend Estates LTS 24-64; thence, continuing West to the line between Sections 9 and 10 of Township 52 North, Range 31 West; also being along the Easterly line of a tract of land deeded to Asa N.B. & Virginia Thomas as appears in Book 433, at Page 326 in the Office of the Recorder; thence, West along said tract 717 feet plus or minus; thence, North along said tract to the Northerly right-of-way of 136th Street, said point being the Southeast corner of a Tract of land deeded to Jay Aurthur and Julie M.C. Hedges as appears in Book 1659 at Page 874, in the Office of the Recorder; thence, West along the South line to the Southwest corner of said Tract; thence, North along the West line to the Easterly right-of-way of U.S. Interstate 35; thence, Northeasterly along said right-of-way to the South line of a Tract of land deeded to Lloyd and Harriet M. Lawhorn as appears in the Book 2017, at Page 861, in the Office of the Recorder; thence, Southeasterly along said South line to the line between Sections 3 and 4 of Township 52 North, Range 31 West; thence, North along said Section line to the Southwest corner of a Tract of land deeded to Everett Quarries Co., Inc. as appears in Book 3312, at Page 11, in the Office of the Recorder; thence, Easterly along the South line of said Tract to the Westerly right-of-way of Petty Road; thence, Northeasterly along the Westerly right of way of Petty Road to the Northerly right-of-way of Northeast 142nd Street to the Southwest corner of Jackbar Estates; thence, Northerly along the West line of Jackbar Estates to the Southerly right-of-way of Northeast 144th Street, also being on the existing City Limit line of Kearney, Missouri, thence, continuing along said City Limit line the following courses, West to the Section line between Sections 3 and 4, Township 52, Range 51; thence North along said line to the Northerly right-of-way of said 144th Street, thence East along said Northerly right-of-way to the Southeast corner of a Tract of land deeded to Gary Wade Shanks as appears in Book 821, at Page 109, in the Office of the Recorder; thence, continuing Northerly and Easterly to the East line of the North 20 acres of the West Half of the Southeast Quarter of Section 34, Township 53, Range 31; thence North along said East line to the North Line of said Tract of land deeded to Gary Wade Shanks, thence, Westerly along said Tract to the westerly right-of-way of Interstate 35; thence, Southwesterly along said right-of-way to the Point of Beginning.
